With an objective to recognize the efforts of students in academics and co-scholastic areas who also reflect ethical values in their lives Bharatiya Vidya Bhavan's Shikshan Bharati, Mumbai has initiated the **SHRI. K. M. MUNSHI PRATIBHA SCHOLARSHIP**.

Applications are invited from eligible Bonafide students of Bharatiya Vidya Bhavan's Vidyashram, NIRDPR Campus, Rajendranagar, Hyderabad studying in Classes VIII to X in the session 2025-2026 who meet the following eligibility criteria.

❖ **Essential Eligibility**

1. Students who have secured 80% or more marks or equivalent grades in the Annual Exam Result or Board Examination and are studying in Classes **VIII to X** in Bhavan's Schools.
2. Achieved not less than **75%** attendance during the previous two academic years. Allowances may be granted for attendance below 75% due to medical reasons.

❖ **Meet one of the following conditions:**

1. Participated in State Level competitions organized by recognized sports federations listed by the Government of India, Ministry of Youth Affairs and Sports, or the state government, or by State/National Level Central Education Boards.
2. Successfully participated in State or Zonal Level Science exhibitions organized by the CBSE or State Education Board within the last two years.
3. Successfully participated in one of the CCA activities organized at the school level.
4. Member of NCC/NSS/Scout & Guide.

❖ **Desirable:**

1. Member of the student council in one of the two previous academic years.
2. Participated in community services in one of the two previous academic years

Interested candidates should collect proforma from the school office from **Mrs.P Aruna Jyothi (Academics)** during all working days between 9.00 a.m. to 3.00 p.m. and submit the same on or before **05.07.2025**

IMPORTANT NOTE:

- Applications received after the **5TH July 2025** will not be accepted.
- The scholarship awarded shall be for a period of one academic/financial year.
- The same student may be considered for a second year if the committee constituted at the time deems the student fit. However, a student shall not be eligible for a third year during their tenure at Bhavan's School.
- The scholarship amount will be Rs.25,000/- or an amount equal to the annual tuition fee, whichever is lower, per eligible student as nominated.
- The scholarship will be disbursed through the school and adjusted against the student's tuition fee during the financial/academic year.
- **Scholarship selection committee shall finalize the names of eligible candidates based on the applications and documents received. The final nomination made by the Kendra on the recommendation of the committee constituted shall be final.**
