- 2. Registration of applications:** 23.12.2024 (Monday) to 31.12.2024(Tuesday)
- 3. Displaying the list of candidates successful in the draw: 10.01.2025 (Friday)**

**Timings: 9.00 am to 01.30 pm from Monday to Friday.**

**9.00 am to 11.00 am on Saturday.**

**Age criteria:**

- For admission to Nursery, not less than 3(three) years and upto 4(four) years as on 31.05.2025 (i.e. born between 01-06-2021 and 31.05.2022).

- 3. Copy of Birth Certificate from Panchayat/ Municipal Corporation along with the original certificate. (The original certificate will be returned after verification).**
- 4. In sibling case (own brother or sister), Xerox copies of sibling's school ID card and BVB Life Membership card.**
- 5. Guardian certificate (if applicable).**
- 6. Certificate of caste / Physically Challenged (SC/BC/ST/PC) (if applicable).**
- 7. Copy of present residence proof (like Telephone bill, Electricity Bill, Passport).**
- 8. Copy of Aadhar Card (Child, Father, Mother). Blood group report of the child.**
